## HENRY BROOKS, THE COLONIAL ANCESTOR

AUTHORITIES differ as to who is the first member of the large family bearing the name of BROOKS to come to America. Several writers state, with great positiveness, that the progenitor of the Brooks family on this side of the Atlantic was one Thomas Brooks who came in the ship "Susan and Ellen" in 1635 when about 18 years of age. Thomas Brooks is the ancestor of a very large family, among whom are many that became very notable.

"The founder of the Brooks family in America arrived in August 1699) in the Delaware (River)," says Frank Willing Leach. Mr. Leach goes on to state that this immigrant, John Brooks with his wife and six children, Jonathan, Elizabeth, George, Abigail, James and Matthew settled in Salem, N.J. John Brooks' lineage was

traced as far back as 1535 to Yorkshire, England. Shortly after the arrival of this family, the father died and was buried in the old Friends' Burying Ground at Salem. A few years after the death of John Brooks, the eldest sons, James and Matthew went over to Pennsylvania and settled on land near the Delaware River which their father had purchased from William Penn. There are today a great many descendants of these two brothers in eastern Pennsylvania.

Extensive researches have been carried on to establish relationship among these two early founders of the Brooks family in America but to date there appears to be no relationship between Thomas Brooks and John Brooks or Henry Brooks, of New England.

It is my opinion, and this opinion is held by several others who have made a study of this subject, that the first Brooks to come to America was not Thomas nor John but Henry. Mackenzie, in his "Colonial Families of the United States" says the ancestor of the Brooks family was Henry Brooks who came to America in 1615 apparently from Scotland since the coat of arms indicated that he is of Scotch ancestry. A writer in the Boston and Eastern Mass. Genealogy (vol. 2, page 652) says, "Henry Brooks came from Scotland and landed in Boston in the year 1630." Unfortunately, neither the date of Henry's arrival nor the place whence he came can be verified as there appears to be no record of either. The first record of Henry Brooks is of March 14, 1638, made in Concord, Mass. and is the date when he was given the rights of a freeman. His next appearance on the colonial records is in Woburn, Mass. where in 1699 he appeared on the tax lists and on subsequent tax lists there until 1657.

We have abundant documentary proof that Henry Brooks was one of the first settlers of Concord. He lived there with his wife, whose name is unknown, four sons and two daughters until about 1648, when he moved to Woburn.

While in Woburn, his wife died. This was prior to 1651 for on March 27, of that year Henry Brooks married Susannah, the widow of Ezekial Richardson of that place. The Brooks home in Woburn was on a tract containing six parcels of land of 178 acres at a section known as "Horn Pond." This tract, with a frame farm house, was purchased from William Brackenburgh of Charlestown, December 20, 1650. In later days, this house stood on what was known as South Street now Main Street and stood there until 1789 when it was torn down by Captain Nathaniel Brooks, a descendent.

Henry Brooks was not only a farmer but a clothier as well. During the years 1669, 1671 and 1672, he served his town as a selectman. There are no records of the date of his birth and our best clue to this date is given in a record of a suit which was instituted in December 1658 wherein he describes himself as being aged 66 years. This places the date of his birth 1591-1592.

We may be satisfied, in spite of faulty records, that Henry Brooks was one of those who left Great Britain in pursuit of religious freedom. The exact date of his arrival will perhaps always be conjecture and the place whence he embarked unknown but

the story of Henry Brooks and his descendants will forever be linked with the great history story of America. He and his descendants are closely connected with the various phases of American history -- its early New England settlements, the organization of new towns, churches and early colonial government. His children and grandchildren took active part in the Indian wars, especially King Philip's and the French and Indian. In the Revolution they fought many of his descendants. Some participated in the War of 1812, and they contributed their share in the development of the Nation through their agricultural pursuits, for most all of the descendants of Timothy were farmers. The first Western Reserve Bank had the assistance of two of his descendants in its founding. The Baptist Church of America has claimed many of Henry Brooks' descendants not only as members but as ministers.

The genealogy herein outlined is largely that of one of Henry Brooks' son, Timothy and although many interesting facts could be included of the other sons of Henry, this book will not permit the space.

Susanna, wife of Henry, was well known in Woburn, her familiar name being, "Goodwife Brooks." She seems to have been a very helpful member of the community as records speak of her as, "an ancient and skillful woman, famous for her attainments in medical science." She died on Sept. 15, 1681.

It will be noted that Henry married Annis, his third wife, at the age of 90.

2. JOHN, (Henry), b. in Concord about the year 1623. On Nov. 1, 1649, he m. Eunice, dau. of Deacon John Mousall. (John Mousall was his brother-in-law as the deacon had married John's sister Sarah in 1650.) Eunice d. and John m. (2) Mary Cranston on Jan. 11, 1683. In 1690, John was a soldier in the Sir William Phips' expedition into Canada. He returned the next year and d. leaving four sons and four dau.

#### TIMOTHY BROOKS, OF CONCORD

Timothy Brooks, son of Henry, was born in Concord, Mass. shortly after the arrival of his parents in America. He moved with his parents to Woburn about 1648-1649 where he married, Mary daughter of John Russell, Sr. on December 21, 1659.

About the year 1670, Timothy and Mary moved to Billerica with their two sons, Timothy Jr. and John. While living in Billerica, Mary gave birth to eight children -- all girls. John Russell, the father-in-law of Timothy Brooks was a strong supporter of the Baptist Church at Billerica and it is doubtless due to this that Timothy and Mary likewise were interested in the tenets of this Church. It was this interest that prompted him, along with fifty-four others to petition the court of New Plymouth for the formation of the township of Swansea. This petition was made in 1667 for the purpose of founding a colony for a band of exiled Welsh Baptists who had come to Massachusetts from Swansea, South Wales in 1649. These Welsh Baptists were under the leadership of their pastor, Rev. John Myles. Pastor Myles' colony originally settled in Dorchester but moved to Rehoboth in 1663. Here they built one of the first Baptist Churches in America.

Rehoboth lies about six miles to the southeast of Swansea which was formed into a township by the Baptists. A church was soon erected here and the Reverend Myles was their pastor. The little colony grew and became quite prosperous until 1675 when Indian troubles began.

History tells us that the colonists in New England experienced but little trouble with the Indians while Chief Massasoit lived but after his death trouble began. His son, who called himself "King Philip," hated the whites and in 1675 he began warfare on

them, killing the people and burning their homes. This war started with an attack Pastor Myles' people as they were going home from church. During this attack, several of the Swansea people were murdered.

All of the towns east of the Connecticut River heard of King Philip's attack at Swansea and they immediately made preparations for safeguarding themselves from attack. In Billerica, by an order of the selectmen, "Timothy Brooks' is allowed for garrison and to entertain Michael Bacon's family and to have two garrisons of soldiers to defend ye mill and himself ye master of ye garrison." The mill referred to was one at the falls of the Shawskin River in the east part of Bedford which Timothy Brooks purchased in 1673, being a part of the Oakes Farm. This farm was purchased from George Farley.

While Timothy Brooks was living in Billerica, his wife died, this was on Sept. 15, 1680. Shortly after, Timothy moved to Swansea. Here he found that many of the former Swansea residents who had scattered during the Indian scare, had returned. Pastor Myles had returned from Boston in 1677 but there were some of his parishioners who never returned to Swansea. Eldad Kinsley, one of the seven founders of the Rehoboth church, and his wife Mehitabel, were among the residents of Swansea in the summer of 1679. In August of that year, Mr. Kinsley died. Mrs. Kinsley married Timothy Brooks in the fall of 1680 and in August 1681, she gave birth to a son, Josiah.

Timothy Brooks was one of the respected citizens of Swansea during his ten years of residence. In 1689, he was elected a representative and on May 20, 1690, he was commissioned a captain.

About the year 1687, a little colony of Baptists located along the river called by the Indians "The Cohanso." The Cohansey River settlement (as it was called by the white settlers) was near the old town of Greenwich which lies near the mouth of the Cohansey River, in Cumberland County, (then Salem county) New Jersey. A few miles up the river from Greenwich the white settlers took up land and built a little log church. Rev. Thomas Killingsworth of Salem was their pastor until his death in 1709.

During the summer of 1690, a band of Welsh Baptists (mostly Seventh-Day worshippers) from Swansea, Mass. came to the Cohansey Settlement. Among these were Timothy Brooks, Sr. Timothy Brooks, Jr., the Bowens, Barretts and Swinneys. The Bowens and the Brooks moved farther inland to the section of Roadstown. Here, on the road leading to the Bridge, (Bridgeton) they bought farms and named their settlement, "Bowentown." The Barretts located on a run which is called to this day, "Barrett Run."

The friends and neighbors of Timothy Brooka were Seventh Day Baptists and they worshipped in the homes of the members of that congregation at "Bowentown," under the leadership of Timothy Brooks, who was their pastor. We are told that "Rev" Timothy Brooks "was not eminent for parts or for learning, yet he was a successful preacher; meek in his carriage; of a sweet and loving temper and always open to conviction, and made the Welsh ministers labor to instruct him in the ways of the Lord more perfectly."

The Seventh Day congregation grew and remained a separate society until 1710 for its members would not lay aside their differences with their friends, the First Day Baptists at Shepherd's Mills. However, in 1710 Timothy Brooks and two of his daughters, as well as many of his society, united with the Cohansey Baptists (First Day) laying aside their differences as predestination, the singing of psalms, the laying on of hands and a few other minor details of doctrine. At the same time, due to the death of Pastor Killingworth, Mr. Brooks was asked to become the pastor of the Cohansey Church. He accepted and remained the pastor until his death in 1715 having won the love of both flocks. It is interesting to note that two of Timothy Brooks' daughters remained true to their Seventh Day doctrine and were, among others, organizers of the Seventh Day Baptist Church of Shiloh where a great many of their descendants still worship.

6. JOHN, (Timothy, Henry), b. Oct. 16, 1662 (in Woburn, Mass.; d. in 1713-1714 (Will dated April 9, 1713. Probated in Swansea, Dec. 20, 1774.)

(The writer has been unable to find any record of John's marriage or children. He appears to have remained in Swansea when his father moved to West Jersey, as there is no mention of John in any Jersey records which the writer has had access to.)

7. JOSIAH, (Timothy, Timothy, Henry), b. Aug. 26, 1681 in Swansea, Mass. He removed to West Jersey with his parents in 1690. Here he married Lucy and settled with his bride at New England Cross Roads, Cumberland Co., d. 1731-32 (intestate).

At Fairfield, now Fairton, in Comberland Co., N.J. there was a settlement of New England and Long Island people as early as 1705. Most of the settlers were located at a section about two miles south east of the Fairton post office at a village which they termed, "New England Cross Roads." Here came Levi Preston with his wife, Abigal Brooks, the daughter of Timothy Sr. about the year 1709. It is quite probable that Josiah Brooks came to this settlement that same time for, in 1710 he was elected constable. He was township collector in 1718 and again in 1728-30, surveyor of the highways in 1718, 1728-30 and overseer of the roads in 1727. The lineage of Josiah is fairly well traced out down to the present time with the exception of the sons of Joel, his grandson, of whom the writer has been unable to trace.)

Was a Freeholder of Cumberland County in 1801-1806. He removed to Warren Township, Trumbull Co., Ohio, in 1810, where he conducted a farm and a tannery with his brother, Oliver. Died in Warren, Ohio, Feb. 3, 1834.

(Both Sidney and Phoebe Rigdon figured in the beginnings of Mormonism. Mr. Rigdon was a confederate of "Prophet" Joseph Smith and it is said to have been Rigdon who furnished Smith with a copy of an unpublished manuscript written by Solomon Spaulding.

The story contained in this manuscript is claimed by many persons to have been the "inspiration" of the book of Mormon. Mr. and Mrs. Rigdon left the Mormons during the "Mormon War" which took place at their settlement at Nauvoo, Ill. over the question of polygamy. Mr. and Mrs. Rigdon were among the many Mormons who differed with Joseph Smith who said that a "new revelation" permitted this practice. The Rigdons returned to Pittsburg and here Sidney served as pastor of the First Baptist Church, having renounced the Mormon faith.)

In his early teens, Thomas enlisted in the Revolutionary War and harrassed the British who were raiding along the shores of the Delaware River. He was captured along with other sailors and taken to New York Harbor and there placed in the prison ship. He was kept in the hold without air and food until ill's hair fell out. Then he was given the choice of enlisting in the British Navy or of "walking the plank." He chose the latter. But instead of inflicting that punishment on him, the British took him to England and there incarcerated him in the Dartmouth prison there where he was kept until he was exchanged just prior to the end of the war. While in prison, we are told that he, with others, caught the dogs who came there to visit and killed and ate them in order to still their pangs of hunger. After he was

released, he returned to America and took up preaching at West Creek, Baptist Church (N.J.) and from West Creek, he went to Dividing Creek in 1816. He served as the pastor of the Baptist Church at that place until 1836.

In about the year 1790, he married Dorcas Rezo, his first wife having died. Miss Rezo was a lady of "unusual intelligence and of French descent.
